- Ballina Arts Centre which is adjacent to the River Moy is actively pursuing the opportunity of hydroelectric potential to power the Building.
- Ballina SEC is currently in the final stages of submitting an application to SEAI for an energy master plan with the ultimate ambition of Ballina becoming Energy Independent.
- Members of the Ballina SEC are actively supporting one of the largest energy users and employers in the town to become carbon neutral.
- On domestic level, Ballina SEC are engaging with the local Credit Union to create a one stop shop for Ballina households to retrofit and upgrade their homes in a financially feasible and hassle free manner.
- One of Ballina's hotels is exploring renewable energy (solar/hydroelectric) options for their business

Carbon sequestration

- As part of National Tree Week 2021, residents of Greenhills Estate supported by Mayo County Council planted 300 native trees in the area with the intention of contributing to the offset of Greenhills carbon footprint.
- Sustainable Ballina Based clothing company, Pure Clothing have begun the planting of 1,000 native trees in their efforts to reduce their carbon footprint for 2021.
- Ballina Stephenites in their role as GAA Green Club have committed to planning over 1,000 trees within the town in conjunction with other community groups and organizations.

Climate adaptation measures eg. Flood alleviation/prevention

• The Ballina Flood Relief scheme is currently putting in place plans for flood alleviation around Ballina. As part of this, they are liaising with the Ballina Green Town initiative to find opportunities for integrating principles of the Green Town vision.

Smarter Travel projects

- Ballina's vision is to become a 10min town, creating transformational walking and cycling infrastructure, which will connect communities with schools, amenities and workplaces. Global leaders in green infrastructure and creators of the 10min town concept have signalled their support for the project and have offered pro-bono advisory support to the efforts.
- Ballina MD has been awarded €150,000 to create a transport master plan that identifies targeted projects to enhance walking and cycling in the town.
- Projects in the pipeline to improve walking and cycling in the town include:
- *The Falcon Trail.* This will connect Ballina town Centre with the continuation of the canal side walkway linking over 1,000 employees of Hollister and Charles River Laboratories along with the staff and guests of Mount Falcon Hotel and the Great National Hotel.
- The Monasteries of the Moy. This is a Greenway project aimed at connecting Ballina and Killala via the two historic Monasteries of Moyne and Rosserk Abbey. This year, funding of €200,000 was announced to extend the trail from Belleek woods to Rosserk.

Biodiversity

- Ballina's Biodiversity Plan developed by Mayo County Council and Heritage Officer Deirdre Cunningham is near completion. Draft to be presented and the next meeting of Ballina Municipal District.
- **Beelieve in Ballina** is an initiative by Ballina Community Clean-up Group due to the decline in the bee population. The initiative sets out to protect areas of biodiversity from grass cutting and the addition of native wildflowers in all of their projects and on all four approach roads towards Ballina town centre.
- The final remaining town centre green space in public ownership has been designated as a town centre park, which will create a green biodiversity corridor in the town centre. This project is a part of a joint motion by all Ballina Councillors to improve biodiversity and carbon sequestration in Ballina.
- Ballina's Biodiversity vision is looking at all opportunities to create green space including rooftops. One example is the rooftop of Ballina Arts Centre, which has been identified as the suitable location for a rooftop garden. This project has unanimous support from the board of Ballina Arts Centre and all Ballina Councillors.
- Ballina Stephenites GAA Club is one of 45 clubs along with two regional venues, selected to participate in Phase One of a new GAA Green Club programme launched December 2020. (Only Club in Mayo and one of four Clubs in Connacht participating)

The GAA Green Club Programme, supported by the County & City Management Association and the local authority Climate Action Regional Offices, is delivered in partnership with the LGFA and Camogie Association, with additional support from expert agencies across the five thematic focus areas of the programme, namely: Energy, Waste, Biodiversity, Water, Travel & Transport. It will see clubs explore a range of sustainability projects designed to enrich their physical and

social environments. The Ballina Stephenites GAA Club is focusing primarily on the Biodiversity theme but will not be limited to this area of work.

• Ballina Stephenites GAA Club is collaborating with St Mary's Secondary School Ballina, creating Natural Pesticides with transition year students, combining biodiversity and enterprise.

Other

The Ballina Green Town initiative is a community inspired and driven initiative that aims to make Ballina Ireland's Greenest town by 2025. As well as already running actions and projects in collaboration with a wide range of cross-community groups and businesses, the group is in the early stages of putting together a number of plans under the area areas of Energy, Mobility, People, Ecology and Economy with fixed targets and roadmaps to achieve these targets. As part of this the group is collaborating with Arup, MVRDV, Elgin Energy and UCD CfIT.

The Mary Robinson Centre

A centre for change that uses the archive and legacy of Mary Robinson, Ireland's first female President, former UN High Commissioner for Human Rights and UN Special Envoy on Climate Change as an educational resource for communities, visitors to Ballina and students and researchers. Mary Robinson's vision for the Centre is that all visitors will leave feeling compelled to take action for change in their own lives. The Centre brings global leaders to the community, partners with Mayo County Council and NUI Galway to arrange events and activities that connect communities, students and researchers with the key themes of Mary's work - human rights, gender equality and climate change.

Ballina Athletics Club

The outdoor athletics track at Ballina Athletics Club will this year upgrade to LED lighting throughout.

Ballina Stephenites GAA Club

Training Pitch, playing pitch, grounds and clubhouse is in the process of upgrading to LED Lighting.

Climate Ready Academy

Climate Ready is a five year initiative that will enable businesses to respond to climate change, offering Irish businesses the practical skills and insights needed to help them respond to climate change. Working with Skillnet Ireland and Chambers Ireland and the Department of Further & Higher Education, the climate academy will be providing support and practical tools to businesses to maximise the opportunities presented, as we transition to a low-carbon economy. In 2030

In 2030, Ballina aims to be a European exemplar for large scale de-carbonization and a model for the green transition.

Thinking Global, Acting Local

The EU plans to become the first carbon neutral continent by 2050, recognising that action and leadership must come from communities to achieve this. We believe Ballina can become a model for towns to de-carbonize by prioritizing local action within a defined framework.

The urgency to respond to climate change has never been more present. In Mayo we are seeing yearly increases in flooding, storms and dry periods and a large reduction in the nature and wildlife on which we depend.

Working towards carbon neutrality needs an ambitious shared vision and collective action. We know change is needed. Ballina is stepping up to this challenge. We recognise our green ambition will bring social, economic and environmental opportunities for Ballina, we understand that the future is green and we will lead the way in this space.

Building the Future

Our vision is for a future where people are prioritized, where household energy consumers become energy producers, where nature blends with our town, is rejuvenated and thrives, where you are never more than 10mins by bike from where you want to be and where products and produce are produced locally and sustainability!

We will achieve this by working with and for our natural systems, with innovative energy solutions, rethinking our economy, re-imagining the way we live and travel and by working together.




Motivation through Inspiration


Ballina Green Town brings together local stakeholders, responding to the urgency of the current situation and exploring ways to empower our community to individual actions while defining town-wide strategies and projects to achieve our goal.

Strategic Action

Our vision includes five interdependent core areas - Energy, Mobility, Economy, Ecology and People. Each has a high level target and three strategies, reflecting best practice, tested methodologies and an understanding of the critical social-ecological systems relating to Ballina, prompting actions from the individual to town-wide.

Aligning the Top-down with the Bottom-up

We know our transition to a green future means aligning our efforts from top-down to bottom-up.

We will create a 'green ecosystem', encouraging community activism, empowering and supporting grass roots pilot projects, providing a 'how to' toolbox of ideas, connections, resources and methods to get started.


We will work with local authorities, government bodies and elected representatives to contribute to the vision. In July 2020 Ballina Municipal District passed a motion to adopt the goal of becoming Ireland's Greenest town by 2025 and to support initiatives to this end, including preserving a town centre green space as a public park and converting flat roof space in town into green roofs.

Collaboration is Key

Collaboration is at the heart of Ballina Green Town. We are working with schools, business, community groups, households and government, and believe everyone has something to offer.

On a specialist level, we're building a passionate team who have offered their time and expertise because they believe in our vision. This includes academic and research teams at UCD, the Centre for Irish Towns (CfIT) and NUIG, energy specialist Elgin and world-leading urban planning and infrastructure experts ARUP and MVRDV.

Our shared vision allows us to coordinate community ambition, policy, projects and expertise while keeping our goal in clear view.



Measuring Success

Measuring success is critical to our vision strategy. A data driven approach will measure our current situation and progress over time. Using GIS, a smart platform/app will allow us measure progress, give support and information and facilitate community feedback.

Ballina's global climate champion Mary Robinson believes 'history has shown, time and time again, that when we come together, we are capable of big things. Change happens when people collectively take action to make our world a better place.' The principle of Meitheal - collaborating and putting people at the heart of the solution - has guided our approach to sustainable development in Ballina to 2030 and beyond.

A **Decarbonising Zone** is an area spatially identified by the local authority, in which a range of climate mitigation measures can co-exist to address local low carbon energy, greenhouse gas emissions and climate needs.

The range of policies and projects developed are specific to the energy and climate characteristics of the spatial area covered by the DZ. This can include a range of technologies and measures addressing electricity, heat, transport, building energy efficiency, carbon sequestration, energy storage, grid frequency/inertia etc.

A Decarbonising Zone should also address the wider co-benefits of air quality, improved health, biodiversity, embodied carbon, agricultural practices, sustainable land management, lower noise levels, waste, water, circular economy etc., and should integrate with smart data and 'smart cities' initiatives (as relevant).

A Decarbonising Zone can also explore the co-benefits of climate adaptation, and examine a range of local measures such as climate proofing, afforestation, green and blue infrastructure, reducing heat island effects, citizen awareness and behavioural change.
